Abilene's North Park Neighborhood (North Central Abilene)

North - Interstate 20
East - Railroad tracks east of N. Treadaway
South - Ambler Avenue
West - Grape Street

Amarillo-Highland Neighborhood Association (Central South Abilene)

North - S. 5th, S. 6th, and S. 7th Streets
East - Vine Street
South - S. 7th Street and S. 14th Street
West - Ross Avenue and Cat Claw Creek

Cedar Creek Neighborhood Association (North East Abilene)

North - Ambler Avenue
East - Judge Ely Boulevard
South - EN 10th Street
West - N. Treadaway

College Heights Neighborhood Association (North Central Abilene)

North - Ambler Avenue and N. 18th Street
East - N. Treadaway Boulevard and Pine Street
South - N. 8th Street
West - Grape Street

Country Meadows Improvement (CMI) (North East Abilene)

North - The alley north of Sunnibrook Court and Cloverleaf Lane
East - ACU Drive and N. Judge Ely Boulevard
South - The alley south of Sunnibrook Court and Cloverleaf Lane
West - The alley west of Sunnibrook Court and Cloverleaf Lane

Fort Phantom Lake Association (North Abilene) (same boundaries for Fort Phantom Area Super Neighborhood)

North - City Limit Lines
East - City Limit Lines
South - Taylor and Jones County Line
West - City Limit Lines

Frenchman's Creek Homeowners Association (South Abilene) off of S. 14th Street just east of Hwy. 83/84

North- lot line for 4515 S. 14th Street
East- lot lines for properties along the west side of Tanglewood Rd.
South- Elm Creek
West- Frenchman's Creek Rd.

Heritage Parks Homeowners Association (Northeast Abilene)

North - Republic Avenue
East - Hwy. 351
South - Hwy. 351
West - East Lake Road

Interested Citizens of North Abilene (ICAN) (Northeast Central Abilene)

North - N. 18th Street
East - N. Treadaway
South - N. 6th Street
West - Pine Street

Old Town Abilene Neighborhood Association (South Central Abilene)

North - S. 3rd Street
East - Alley west of Butternut Street
South - S. 11th Street
West - Alley west of Meander Street to S. 5th, alley west of Vine to 11th

Sears Revitalization Committee (North West Abilene) (same boundary as Sears Park Area Super Neighborhood)

North - Interstate 20
East - Grape Street
South - N. 18th Street and Ambler Avenue
West - Mockingbird Lane and US Highway 277

Town West Neighborhood Association and Downtown Homeowners Association (Northwest Central Abilene) (these boundaries are very generalized; the members are considering new boundaries)

North - N. 12th Street
East - Hickory Street
South - N. 1st Street
West - Cat Claw Creek
