## **Itinerant Business Regulations**

1. The itinerant business must be located on property that is zoned to allow the proposed use.
2. The itinerant business must have the written permission of the property owner.
3. No more than one itinerant business may be on a property at one time. No parcel may have an itinerant business on site for more than 36 days in a calendar year. The 36 days may be used at one time or may be divided in any way. A permit for an itinerant business does not take the place of other approvals or permits that may be required by other City departments or governmental agencies.
4. The following businesses shall be prohibited from obtaining an itinerant business permit:
  - Sales of knives, firearms or other weapons
  - Sales of live animals
  - Sales of alcoholic beverages
  - Adult Entertainment as defined by this ordinance
5. Any tent, trailer or other structure housing the itinerant business must be set back a **minimum of 10 feet from all property lines.**
6. Nothing related to the itinerant business (including but not limited to signs, inventory, parking, storage, tents) may occur in or be placed in any of the following areas:
  - The vision clearance triangle
  - Fire lane
  - Drainage Easement
  - Any area deemed a hazard to the general public health, safety, or welfare by any official of the City of Abilene or any other Governmental agency.
7. A violation of this ordinance may result in any of the following:
  - a. Penalties in accordance with any applicable penal provision
  - b. Immediate termination of business activity and removal of all itinerant business related items from the property
8. **The approved permit must be available for inspection at the business premises at all times that the business is operating.**
