APD Arrests Multiple Suspects in Ongoing Investigation

ABILENE, TX – The Abilene Police Department Fraud Unit has been conducting an Organized Crime investigation over the past two months. They recently obtained warrants on the top three suspects. On December 29, 2015 Fraud Detectives executed a search warrant in the 2500 Block of Stonecrest Drive. A known Forgery suspect, Randal Alan Day W/M 06/05/1961, was subsequently arrested.

During the investigation, on Thursday, December 31, 2015, Detectives contacted several persons at a motel in the 700 Block of East Highway 80 where one of the wanted Forgery Suspects had been staying. Upon entry, a large amount of methamphetamine was located. Roianna Carrion HF 03/16/1990, Priscilla Del Rio H/F 05/10/1988, and John Robert Davis WM 09/11/1979 were arrested for 3rd Degree Felony Possession of Methamphetamine. Detectives located the wanted Forgery suspect, Scott Day 01/21/1983, walking in the 1500 Block of North 12th Street shortly after leaving the hotel.

Toby Jack Davee, W/M 09/18/1978, was located in a rural house off County Road 100 in Hamby, TX. He was in possession of numerous evidentiary items and was arrested for his part in the Forgeries. Subsequent to this contact, Heather Baugh WF 11/26/1988 was arrested for Possession of Methamphetamine, a State Jail Felony. John Hlava WM 07/13/1983 was also at the residence and found to have outstanding warrants for his arrest.

The investigation continues into the link between the eight suspects as well as others not arrested at this time. These suspects have been dealing in the distribution of stolen checks, credit/debit cards, and ID's that had been taken from vehicles. Citizens are again encouraged to avoid leaving personal information or valuables in vehicles.

Through this investigation eight, persons were arrested for narcotics and financial crimes.
